WHEREAS, the Board would like authorize METRO staff, with Board Committee input to design, implement, and evaluate a pilot program providing free access to qualified veterans on METRO's High Occupancy Vehicle/High Occupancy Toll Lanes; and

WHEREAS, the pilot program to allow free access to qualified veterans on METRO's High Occupancy Vehicle/High Occupancy Toll Lanes should be designed in a way that it does not negatively impact the speed or reliability of carpool, vanpool, and bus service on the HOV/HOT lanes.
