#### METRO Small Business Program Policy

- Promotes equal opportunity and non-discrimination in METRO's procurement activities
- Created to provide opportunities for small and disadvantaged businesses
- Race and gender neutral
- Small Business certification based on personal net worth and industry size standards



#### OFFICE OF SMALL BUSINESS

- Serves as an advocate for small and disadvantaged businesses
- Supports activities to maximize participation in METRO's procurement and contracting activities
- Provides information, training and outreach regarding opportunities for SB/DBE participation on METRO contracts
- Monitors SB/DBE utilization on contracts with participation goals



#### **METRO Goals**

- Small Business Goals
  - Established on a contract-by-contract basis
  - 35% small business annual commitment
  - No DBE goals on contracts
- DBE Triennial Goals
  - FTA mandated reporting only
  - Calculation in accordance with FTA regulations
  - Projection of Federally funded projects in FY23-FY25
  - Determined by available DBEs and total firms

#### Purpose Of Public Meeting

• Section 49 Code of Federal Regulations Part 26 requires METRO to establish an overall goal for FY 2023-2025 for participation of Disadvantaged Business Enterprises (DBE's) in its contracts which are funded by the Federal Transit Administration.

## Step One - Development of Base Figure

- 1. Identified the anticipated fiscal year 2023 2025 federally funded projects.
- 2. Identified the applicable NAICS Codes from the anticipated projects.
- 3. Identified the applicable DBE firms based on NAICS Codes.
- 4. Identified the applicable firms available in our region based on NAICS Codes.
- 5. Calculated DBE availability based on above numbers.
- 6. Calculated weighted average of projects and DBE availability for each type of work.
